

# Regulations Camping pitches Camping Julianahoeve

Camping Julianahoeve is affiliated with RECRON, which means that the general RECRON-conditions apply on our campground. These conditions can be obtained at the reception. Besides the RECRON conditions, we also apply the below stated regulations of Camping Julianahoeve;

# Article 1 : Camping pitches

At your day of arrival, the camping pitch is available from 13:00. Time of departure is before 11:00.

# Article 2 : Payment method

Two weeks after reservation, 50% of the accommodation costs must be paid. The remaining amount must be paid 4 weeks prior to your arrival. In case the second payment term is not met, we will rent the camping pitch to others.

#### Article 3 : Register

Upon arrival, the recreant needs to visit the reception first (during opening hours). Please let us know during check-in when there are any changes regarding the persons signed up.

#### Article 4 : Access

- 1. Each renter receives a card at check-in to open the barriers. You will have to return the card to the reception at the end of your stay.
- 2. It is not allowed to pass the card on to third parties.
- 3. The deposit for **Luxury sites** is €50. The deposit has to be paid in advance, and will be transferred back to your bank account after departure.

#### Article 5 : Family campground

We do not offer residence to youth aged under 21 travelling without adults. Youth under 21 years may only stay overnight at the campground when at least one of the parents or legal guardians stays at the same camping field. Youth above 21 travelling in a group will only be accepted after permission.

#### Article 6 : Day visitors

Day visitors need to leave the campground before 23:00. Please be sure that your day visitors follow our rules. We consider you to be responsible for the behavior of your guests. Day visitors do not have access to the swimming pool during holiday periods and weekends.

# Article 7 : Pets

Pets are not allowed on our campground.

#### Article 8 : Waste water

The waste water must be collected and disposed in the appropriate drains and chemical toilets located near the sanitary buildings at Park Reiger and Zeemeeuw.

#### Article 9 : Camping pitch

- Maximal 1 additional tent of max. 4m2 is allowed.
- Do not dig on the site.
- A ground cloth may only be placed underneath the caravan awning. It is not allowed to place it underneath the additional canopy.
- The caravan has to be placed alongside the hedge.
- Electricity closets, sewage and water wells should be kept clear at all times.
- A maximum of 6 persons is allowed per pitch.

#### Article 10 : Fire hazards

It is not permitted to make open fires (e.g. a bonfire). The use of barbeques is allowed, provided that it is done in a safe way and that it does not disturb other guests.

#### Article 11 : Car- or motor usage

- 1. We request you to minimize the use of motorize vehicles on the campground and to drive at walking speed.
- At your arrival, you will receive a sticker which should be fixed to your windscreen during your stay. Cars without sticker do not have access to our campground.
- It is possible to park one car at the pitch. A second car or trailer can be parked at the parking lanes in front of the gate.

# Article 12 : Silence

- 1. One has to take into account that it has to be silent at the campground and that it is not allowed to drive with motorized vehicles between 23:00 and 07:00. During these times, the gate can only be opened in case of emergency. Noise in the broadest sense of the term should be avoided at all times.
- 2. In case of repeated nuisance, the management reserves the right to deny access to the campground at all times.
- In case the reception has closed and an emergency occurs, you can use the intercom at the main gate to inform the superintendents/security.

# Article 13 : Sanitary buildings

- Please keep the toilets and showers clean! Children under the age of 6 may only use the toilets/showers under supervision. Please do not throw sanitary towels, diapers and such in the toilet.
- 2. It is not permitted to clean vegetables ,fish and such in the sinks that are located in the sanitary buildings.

# Article 14 : Waste management

The campground offers opportunities to separate your waste. Garbage needs to be disposed in sealed bags. Please do not forget to close the garbage bins to prevent odour. Separate containers are available for green waste, plastic, paper, and glass.

# Article 15 : Sport

To protect people's property, it is prohibited to play ball games at the street or on the camping fields. Ball games can be played at the designated sport fields. In case activities are organized at the sport fields, it is only possible to have access to the field when signed up for these activities.

# Article 16 : Disordered behavior

The management reserves the right to deny access to people who behave disorderly and who constantly ignore the prescribed rules.

# Article 17 : Use of alcohol

Consumption of alcoholic beverages is only allowed in and around the rented chalet/bungalow, at the restaurant or café located at the center square of our campground. Parents or guardians are responsible for the consumption of alcohol among their children at all times.

# Article 18 : Cancellation insurance

Of course we assume that you will spend your holiday at our campground. Though circumstances may occur which may lead to cancellation or early departure. Therefore we suggest you to arrange a travel insurance.
